THE CENSUS IS COMING

In 2020 there will be a census count completed. The U.S. Census Bureau has already contacted City Hall to let us know they will be in our area and are looking for assistance with this process. They would like our help

to spread the word about who they are and what they are doing and why it is important.

Here are a few helpful facts from USAFacts.org about the Census

Who participates in the Census:

Everyone who has established a residence in the US is counted, including individuals with work visas, international students, and unauthorized immigrants, but excluding temporary visitors such as tourists.

When should I expect to receive my survey?

You don't need to sign-up; the Census Bureau is hard at work making sure they get to you. You will receive a letter in the mail between March 12th -20th. Those who do not respond online or by mail to the initial requests are visited in person by a team of Census surveyors.

What is the need for a "complete count?"

Data from the Census is used for a variety of purposes. It determines legislative districts and representation and sets eligibility for government programs like housing assistance. The data is also used to allocate nearly \$700 billion, or 13% of all government spending, to government grants and programs. When fewer people respond than actually live in a given area, the data may under-allocate elected representatives or reduce the amount of funding given to that community.

PET REGISTRATION

Pet Registration for 2020 is now open! Register your pet by picking up the form at City Hall or download the form at www.visitmoville.com. The annual cost to register your pet is \$5 if they are neutered/spayed and \$10 for non-neutered/spayed pets.



Please return form, fee and a copy of current vaccination record to City Hall. Feel free to use the overnight drop box and staff will mail 2020 tags. Pets not licensed by March 31st will be assessed a \$3.00 per month late fee and will be subject to violation of City Ordinances and Fines.

SNOW EMERGENCY

The City of Moville has a snow parking ordinance for winter months. This Ordinance is to help get our streets plowed quickly and avoid personal property damage.

PARKING DURING SNOW EMERGENCY. Do not park any vehicle on any public street, alley, or Cityowned off-street during a Snow Emergency unless the snow has been removed from said area and snow has stopped accumulating. Whenever an unauthorized vehicle is found, a municipal officer can have the vehicle towed.

A snow emergency parking ban will continue through the duration of the snow or ice storm and the seventytwo (72) hour period after cessation of the storm.

DESIGNATED PARKING AREAS. Parking is permitted during a snow emergency in two designated parking areas: Haskell Pool parking lot and on the west side of the 200 block of North Fourth Street (soccer fields parking lot) for periods of up to seventy-two (72) hours of continuous use.

MUNICIPAL INFRACTION. Parking a vehicle in violation of this ordinance four or more times between November 1 and May 1 or leaving a vehicle in a designated parking area for over seventy-two (72) hours shall constitute a Municipal Infraction. A civil penalty of \$100 shall be imposed for each violation. Each day a violation continues shall constitute an additional infraction.
