Conolly motioned to publish notice of the propsal for three weeks and host a public hearing on February 3, 2016 to hear public comments, seconded by Schmidt, all ayes motion carried. If additional proposal are submitted they will be reviewed at the February 3<sup>rd</sup> meeting.

Thomas motioned to accept bid proposal from Electrical Environmentals for generator in amount of \$43,780, seconded by Lubbers, all ayes, motion carried.

Council discussed the International Property Maintenace Code that is being proposed, at this time the matter will be tabled so the Building Inspector can attend a meeting to review his procedures and answer any questions the Council has concerning the Code. Planning review for Februray 3<sup>rd</sup>.

Council and Police Department discussed the Trailer and Dumpster Ordinance and the Snow Parking Ordinance. The Police Department will prepare some samples to change the language and review with the Council in February.
