The council reviewed the 2017 Resolution to appoint banking institutions. The council amended the limits on banking deposits from one million to 1.5 million dollars. Thomas motioned to approve the resolution with this change, seconded by Schmidt. Ayes, motion carries.

The council reviewed the 2017 Resolution to appoint Records Custodians. Schmidt motioned to approve the resolution, Conolly seconded. Ayes, motion carries.

Mike Weaver gave a public works update.

Jereme Muller gave a Police Department Update.

The disposition of 24 S. 2nd Street was discussed. Pat Rogers has submitted a proposed specific site plan that will be denied by our building inspector due to setbacks. From there it will go to the Variance Board for review.

Attorney Metcalf discussed the revision of the plat for 150th St near CPS. There is no further City action required at this point. Metcalf will ensure the project is completed by the other responsible parties.

The council reviewed the Liquor License transfer of Jeff's Bar Too from 509 ½ Frontage Road to 607 Frontage Road. Bauer motioned to approve the transfer, Schmidt seconds. Ayes, motion carries.

The school heard an update regarding the property at 102 S. 4th Street. The school will talk to the Fair Board at their next meeting regarding possible permission to access the property via Fair Street near bus parking.

The council discussed 2017-2018 Budget and made recommendations to Department heads for adjustments.
