Moville City Council

March 1, 2017

Mayor James Fisher called the meeting to order at around 6:00pm. Roll Call: Nate Bauer, Tom Conolly, Kirk Lubbers, Jake Thomas are present. Bruce Schmidt arrived around 6:05pm. Thomas motioned to approve the agenda, seconded by Conolly. Ayes, motion carries. Bauer motioned to approve minutes from the meeting on February 15, 2017, seconded by Conolly. Ayes, motion carries.

Guests include Police Chief Jereme Muller, Jonathan Kesselring, Assistant Police Chief Bill Brooks and Aaron Corley.

There was no fire department update as Chief Jerry Sailer was not in attendance.

The disposition of 24 S. 2nsd Street was discussed. Pat Rogers submitted a proposed specific site plan that was denied by our building inspector due to set backs. Rogers has appealed to the Board of Adjustments. Dan McCoy from the Board of Adjustments took the information for review on February 23rd.

Mayor Fisher stated that he asked Scott Gernhart to survey the lot at 102 S. 4th Street; he hasn't gotten a response from Scott. Also, the Woodbury Central School Superintendent Doug Glackin has signed the letter of understanding that was discussed at the last council meeting.

Mayor Fisher proposed adding the privilege of native carryout wine to Casey's current liquor license. Bauer motioned to approve the addition of native carryout wine to the current liquor license, Lubbers seconded. Ayes, motion carries.

At around 6:07pm Mayor Fisher opened /closed the budget hearing for 2017/2018 budget. There was a motion by Conolly to approve the 2017-2018 budget, Lubbers seconded. Ayes: Bauer, Thomas, Lubbers, Conolly. Nay: Schmidt.

Mayor Fisher brought forward an ordinance restricting outbuildings in Moville. Attorney Metcalf discussed the proposed ordinance and outlined the details of it with regard to no building permits will be approved for portable storage to be used as permanent storage accessory building. Also, the accessory building shall be constructed and finished in the materials customary to residential construction. Any current storage units will be permitted. Conolly motioned to approve the ordinance, Lubbers seconded the motion. Ayes, motion carries.

Chief Muller discussed allowing ATV's on city streets, his main concern would be with the safety of kids and also how they would be registered. In the town of Remsen they require ATV's to be registered with the city, with registration the owner would submit a photo of the ATV and the serial number. The City would then give the owner a sticker for the ATV. Chief Muller wasn't sure of a cost for registration as cost wasn't the motivator for registration. Kesselring stated that as an ATV owner he would have no issue paying to register it, just that he wants to be able to ride it legally in Moville. It was decided that Attorney Metcalf would add information about ATV's to the current UTV ordinance then the council would review/discuss and take action on it.

There was a sign up for 2017 committees passed around to the Council members.
