#### **AUTOMATIC BILL PAY:**

#### CITY ORDINANCES

The following City Code has been adopted by Moville and is currently in effect. 3-11-03 DUTY OF OWNER TO CUT OR DESTROY. The owner or owners of each lot and parcel of ground within the corporate limits of the City shall cut or destroy all weeds, as defined above, before they bloom or seed, and in any event, by the 15<sup>th</sup> day of the months of May, June, July, August, September and October, respectively, of each year.

**3-11-04 FAILURE TO COMPLY.** In the event the owner of any lot or parcel of ground neglects or fails to comply with the provisions of Section 3-11-03, the Director of Public Works or his assigns shall proceed to mow, cut, or remove the weeds as required by Section 3-11-03 and report the actual cost of the labor and material to the City Council. Upon the approval of the report by the City Council, the City Clerk shall forthwith send a statement for such actual cost together with an additional ten per cent (10%) thereof for administrative costs, but in any event, not less than a total charge of \$50.00 to the owner at the address used for mailing of tax statements. If this statement is not paid within thirty (30) days, the City Council may, by resolution, levy and assess the aforesaid charges against the lot or parcel of land, and in such event, the resolution shall be certified by the City Clerk to the County Treasurer and be entered upon the books of the County Treasurer as a charge against the property and the owner or owners thereof, to be paid and collected in the same manner as property taxes. The charges set forth above may also be collected by suit or otherwise in the name of the City against the owner, and all such costs and expenses collected shall be placed in the General Fund of the City.

**3-11-05 NOTICE.** Notice of the time constraints in Section 3-11-03 shall be published pursuant to Section 362.3 of the *Code of Iowa* not less than four (4) and not more than twenty (20) days prior to the 15<sup>th</sup> day of each of the months of May, June, July, August, September and October, respectively, of each year. Upon publication of each notice, an owner is deemed to have notice of the provisions hereof.

#### 3-11-06 AUTHORITY TO ENTER LAND.

In case of substantial failure by the owner or party in possession or control of any land to comply with this chapter, the Director of Public Works or his assigns shall have full power and authority to enter upon any land within the City for the purpose of destroying any weeds, vines, brush or other growths which constitute a health, safety or fire hazard. Entry may be made without the consent of the owner or person in possession or control of the land.

#### SPORTS COURT UPDATE


Have you seen the vibrant sports court on Main Street? How lucky are we to have that in our city! We are very thankful for all of the effort MCDAI put forward and all of the individuals that provided monetary contributions toward this project.

Some have asked what makes this surface different from our old court? The rubber tiles that are used for the court delivers a better combination of shock absorption (protection from injury), ball response, traction, and playability and it is easier on joins and ligaments. This really is a state-of-the-art surface we are fortunate enough to have to play on here in Moville.

With that, there are a few guidelines that we ask that you follow: *No roller skates, in-line skates, skateboards, bicycles, tricycles or hockey play.*

Register your pet for 2017 by picking up the form at City Hall or download it at www.visitmoville.com. The annual cost to register your pet is \$5 if they are neutered/spayed and \$10 for non-neutered/spayed pets.

Please return form, fee and a copy of current vaccination record to City Hall. Feel free to use the overnight drop box and staff will mail the 2017 tags registration. Pets not licensed by May 31st will be assessed a \$3.00 per month late fee and may be subject to violation of City Ordinances and Fines.
