CITY ELECTIONS

City Elections!! This year there are two open seats for City Council and one for the Mayor position. You can pick up paperwork from City Hall and will need to be returned by August 6th 2025 if you are interested for running for either position.

The process starts when individuals interested in running for the respective positions acquire an "Affidavit of Candidacy" and "Nomination Petition for Non-Partisan Office" papers. The candidate must garner at least 10 signatures from registered Moville voters; after those signatures have been received the documents are turned into City Hall by September 18, 2025 to be filed in the County Auditor's Office.

From there it is up to the voters to see who will serve as Mayor City Council members for the next two to four years.

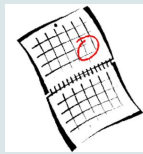

REMINDERS



•**Mowing** Do not mow grass clippings into the streets. The grass clippings clog the storm sewers and can cause sewer backups. It is expensive for both the city and home owner.

•**Weed/Mowing Complaints** Grass and/or weeds need to be mowed by the 15th of the month from May through October. If grass and/or weeds are not mowed by that time the city crew will mow the yard. The fee for mowing and cutting weeds shall be one hundred dollars (\$100) per hour plus administrative fees, those fees will be assessed to the homeowner. See the newspaper for monthly notice.



•**Operating Golf Carts** Golf carts are allowed on city streets by persons possessing a valid driver's license and insurance. However, a golf cart shall not be operated upon Hwy 140. The golf cart needs to have a **slow moving vehicle sign** and a safety flag and operate on the streets only from sunrise to sunset.

•**Operating ATV/UTV's** ATV/UTV's are allowed on city streets by persons possessing a valid driver's license and insurance. **A reflective sign with an orange triangle and dark red border is required.**

PET LICENSE REMINDER

Pets are required to be registered with the City of Moville each year. To register your pet provide a completed pet registration form along with a copy of updated vaccinations to City Hall, once those documents have been submitted tags will be provided for the current year.

License: Pets are due to be registered by the end of February new year.

The late fees are as follows:

At Large: Pets running at large will be impounded. Owners will be required to pay a impounding and/or licensing fee before the animal will be released back to the owner.

Nuisance: Pets causing a disturbance by excessive barking or other noise making to such an extent as to annoy or disturb persons in the vicinity of the dog could receive a warning letter and/or Municipal Infraction depending on the number of occurrences of the incident.

Animal Bites: Any animal found to have bitten a person or other animal shall be confined as directed by the Mayor. The animal can then be subject to removal from the City and/or the owner can be fined.

If there are any further questions about any of the information please call City Hall or the Police Department if there are issues or concerns with animals that are at large, a nuisance, or dangerous.

UTILITY BILL OPTIONS

Moville residents have many options when it comes to paying utility bills. The following are payment options: online, in person at City Hall (or in the drop box on the East side of the building), by mail or Automatic bill pay or (ACH).

The link to pay your bill online by debit or credit card can be found on the City website (visitmoville.com). Add your account number, follow the prompts and pay your bill online.

ACH (or automatic withdrawal) is another popular option, complete the form and we take care of the rest. An automatic withdrawal from your account will be made around the 8th of the month. This is a quick and easy way to pay your bill and guarantee your payment will never be late.

Also, residents now have the ability to receive utility bills via email. If you would like to be set up to receive your utility bill via email please contact City Hall to add your email information to your account.
