Deb Vohs speaks on behalf of MCDAI on how they can assist with fixing up the stone on the side of the Main Street Pavilion before Moville Daze. Supervisor Smith of Public Works communicated that it isn't a matter of money as much as it is workload on the Public Works. Jeff Sparks speaks at open forum asking why our Police Department Officers do not live within Moville city limits. Mayor Linden explains it is not a requirement of this position.

Chief Jerry Sailer gave a Fire Department update for the month of February. He noted there were 9 calls for service to include a vehicle, 3 structure, 4 field fires, and one under investigation. Chief Sailer informs the council they typically respond 40-45 incidents per year and we are currently at 35 just in the past few months! The Fire Department attended a Go, No Go program training and NW Iowa Regional Fire School. There is a County wide burn ban going on in our area.

Public Works Supervisor Pat Smith updates the council on ISG Engineering details on the Water Improvement Project design to include connecting the existing water system.

- Bainbridge poured intersection, working on wall and sidewalks
- Fertilized and dethatched parks and MYRA ball fields
- Helped with Woodbury Central community clean-up day
- Began work on the pool
- Checked siren batteries and all emergency lighting

Hayworth motions to approve 1<sup>st</sup> reading of Ordinance 2025-05 establishing a no parking zone on S 6<sup>th</sup> Street by new the Medical Clinic, seconded by Malm. Ayes, motion carries. Hayworth motions to waive 2<sup>nd</sup> and 3<sup>rd</sup> reading, seconded by Rapp. Ayes, motion carries. Mellies motions to adopt Ordinance 2025-05, seconded by Parks. Ayes, motion carries.

Mellies motions to approve City Inspector/Code Enforcement 28E Agreement for the town of Akron with the new rates per hour in place, seconded by Rapp. Ayes, motion carries.
