

Moville City Council –Wednesday, November 6, 2024 at 6:30 pm

Roll Call: Paul Malm, via zoom, John Parks, Bret Hayworth, Jared Rapp, Calvin Mellies all present. Parks motions to approve agenda, seconded by Malm. Ayes, motion carries. Malm motions to approve the minutes from the last meeting, seconded by Mellies. Ayes, motion carries. Parks motions to approve the utility trial balance, seconded by Rapp. Ayes, motion carries. Guests present include: Chad Thompson, Pat Smith, Jadin Collins, Dawn Thomas, Jerry Sailer, Jim Fisher, Michael Weaver and Joe Barnes. Jim Fisher speaks at Open Forum. He feels Moville needs a part time City Coordinator to set up youth summer work programs, organize events such as Saturday in the Park, and even set up fun tournaments for Pickle ball, disc Frisbee, and basketball just to name a few! Jim Fisher also asked the Council as City Leaders to approach the Woodbury County Board of Supervisors regarding the need to fill the position again for an Economic Development Director. City Clerk Peterson also speaks at Open forum promoting the Community Catalyst Building Remediation Program which stimulates economic growth in the community, can improve appearances and safety, increase population, or property values and may offer additional jobs. Fire Chief Jerry Sailer shares an update on the Fire Department:

- 10 calls for service in October to include a combine, several field fires, a motor vehicle accident and carbon monoxide poisoning
- Training in Kingsley for Mass Casualty Disaster Drill
- Performed Mock Fire Drill training and timing
- Truck checks went well had dead batteries which they will organize a battery check schedule
- Participated in Career Day and Fire Prevention week at Woodbury Central School
- Present for the Halloween Parade on Main Street

Police Chief Joe Barnes gave a brief update on the Police Department for the month of October:

- 36 calls for service, 21 traffic citations, 29 written warnings, 1 arrest
- Completed Fire Arms Training/ Officers are Certified
- Officer Alavez attended training in Aurelia on case laws, legal changes and standards

Hayworth motions to approve transferring funds from budgeted New Equipment to Equipment Maintenance for the PD to pay

Hayworth introduces Ordinance 2024-8 and motions to approve the 1st reading: AMENDING ORDINANCE NOS. 2018-038, 2021-5, AND 2023-5, AND PROVIDING THAT GENERAL PROPERTY TAXES LEVIED AND COLLECTED EACH YEAR **ON CERTAIN PROPERTY** LOCATED WITHIN THE FRONTAGE ROAD URBAN RENEWAL AREA, IN CITY OF MOVILLE, COUNTY OF WOODBURY, STATE OF IOWA, BY AND FOR THE BENEFIT OF THE STATE OF IOWA, CITY OF MOVILLE, COUNTY OF WOODBURY, WOODBURY CENTRAL COMMUNITY SCHOOL DISTRICT, AND OTHER TAXING DISTRICTS, BE PAID TO A SPECIAL FUND FOR PAYMENT OF PRINCIPAL AND INTEREST ON LOANS, MONIES ADVANCED TO AND INDEBTEDNESS, INCLUDING BONDS ISSUED OR TO BE ISSUED, INCURRED BY THE CITY IN CONNECTION WITH THE FRONTAGE ROAD URBAN RENEWAL AREA ("**ADDITION OF VACATED ROW TO 2023 ORDINANCE PARCEL**"), seconded by Rapp. Ayes, motion carries. Hayworth motions to waive the 2nd and 3rd readings of Ordinance 2024-8, seconded by Parks. Ayes, motion carried. Hayworth motions to adopt Ordinance 2024-8, seconded by Mellies. Ayes, motion carries. Parks motions to approve Resolution 2024-39 to roll the city's current CD in the amount of \$206,608.80 with Security National Bank into a 182-day CD at 4.65% annual percentage, seconded by Malm. Ayes, motion carries.
