

Moville City Council Meeting Wednesday September 20, 2023

Mayor Fisher calls the meeting to order at around 5:30 pm. Roll Call: John Parks, Tom Conolly are present. Paul Malm attends via zoom and Bret Hayworth joins at 6:24pm. Joel Robinson is absent. Parks motions to approve agenda, seconded by Conolly. Ayes, motion carries. Malm motions to approve minutes from the September 6th meeting. Conolly seconds. Ayes, motions carries. Parks motioned to approve the claims for the month, seconded by Conolly. Ayes, motion carries. Conolly motions to approve the August Treasurer's report, seconded by Malm. Ayes, motion carries. Permit for a garage at 425 Jackson was approved by Building Inspector Christiansen. Guests present include Mike Weaver, Joe Barnes, Dave Christiansen, Leo Woods and Chad Thompson. Leo Woods from KCAU spoke about the Skycam and potential sponsorship options during Open Forum.

Superintendent Mike Weaver gave a Public Works update. There was discussion about easement/option to purchase test well drilling site; Attorney Chad Thompson has been working with the attorney for a local land owner for the potential of land purchase south of town. Initially it was though only two acres were needed, it has now been updated to three acres needed for the well testing sites. Conolly motions to take action on easement/option to purchase test well drilling site. Parks seconds. Ayes, motions carries. Parks then motioned to approve ISG to send out RFP's for test well proposals to interested contractors. Conolly seconds. Ayes, motion carries.

Inspector Dave Christensen gives a Code Enforcement update. He has been working on nuisance remediation by sending letters and Official Notices and residents make many great improvements. Currently there are ten towns that Christiansen is working on code enforcement with through the 28E Agreement.

Conolly motioned to approve the 2023 Street Finance Report. Malm seconds. Ayes, motion carries.

Parks motioned to approve the 28E contact for Hinton. Conolly seconds. Ayes, motion carries.

Council discussed the range of pay for potential City Clerks. Parks motioned to approve the range of pay between \$22-25/per hour. Conolly seconds. Ayes. Motion carries.

Council reviews first reading of Ordinance 2023-4 changing the start time of the meetings of the Moville City Council to 6:30 pm. Conolly motions approve the first reading of Ordinance 2023-4 changing the start time of the Moville City Council meetings from 5:30 pm to 6:30pm. Parks Seconds. Ayes, motion carries. Conolly motions to wave the second and third reading of Ordinance 2023-4 changing meeting start time to 6:30pm, seconded by Hayworth. Ayes, motion carries. Conolly motions final adoption of Ordinance 2023-4 changing meeting stat time from 5:30 pm to 6:30pm, seconded by Malm. Ayes, motion carries.

With no further business Conolly motions to adjourn around 6:43pm and Hayworth seconded. All ayes, motion carries-meeting closed.
