### PREVENT FROZEN PIPES WITH THESE TIPS

Do you know how to prevent water pipes in your home from freezing or how to thaw them if they do freeze? A few valuable tips can save you the hassle of dealing with frozen pipes.

Make sure to insulate pipes in unheated areas or against outside walls and seal any leaks that may let cold air in. Keep your garage door closed if your water meter is located in that area. Disconnect your garden hose and shut off the water supply to outside faucets. If the temperature gets extremely cold, open cabinet doors under sinks to allow heat to get to pipes and let a faucet drip at a trickle if possible.

### 2017 PET REGISTRATION REMINDER

Pet Registration starts January 1, 2017. Register your pet by picking up the form at City Hall or download the form at www.visitmoville.com. The annual cost to register your pet is \$5 if they are neutered and \$10 for non-neutered pets.

Please return form, fee and a copy of current vaccination record to City Hall. Feel free to use the overnight drop box and staff will mail the 2017 tags registration. Pets not licensed by May 31st will be assessed a \$3.00 per month late fee and may be subject to violation of City Ordinances and Fines.

It is the duty of the owner to keep sidewalks abutting the owner's property clear of the natural accumulations of snow or ice. If the owner fails to do so within twenty four (24) hours after deposit of accumulation, the Mayor may have the natural accumulations of snow or ice removed without notice to the property owner.

The Mayor shall give the Council an itemized and verified statement of the removal costs and a legal description of the property at the next regular Council meeting. The costs shall be reviewed by the Council and assessed against the property as taxes.

### WATER SHUT OFF PROCEDURES:

Monthly bills are mailed the 1st of each month and due the 20th.

If payment is not received by the 30th, a shut-off notice is mailed with next bill. This notice indicates when the late payment is due. If arrangements are not made by due date, water service can be shut off.

Before service can be restored, a \$25 reconnect fee + full payment of past due amount is required.

### WATER SHUT-OFF/CURB STOP MARKING

Please make sure that your curb stop/water shut-off is marked so when it is time for snow removal, it does not get damaged or broken. In the event of a broken/damaged curb stop/water shut-off due to the property owner removing snow, the cost of the repair and/or replacement of the stop will be the responsibility of the home owner. A little prevention can go a long way to keep this from occurring. Thank you for your help!

### HELP THE FIRE DEPARTMENT

The Fire Department requests the help of residents to keep snow away from hydrants that are in your neighborhood and near your home.

We would also like to remind you of your responsibility to have your house number prominently displayed facing the street so that our Emergency Responders can find you!





Have you seen "SNOW PARKING IN EFFECT" aired on the local TV stations and wondered what that means? The City Council requests your cooperation in keeping vehicles off city streets during a snow emergency to allow city crews to safely remove snow. We recommend that before you retire to your home for the evening that you move all vehicles off city streets to avoid citations. Thank you for your cooperation.

### **GUIDELINES FOR SNOW EMERGENCY**

The City of Moville has adopted a snow parking ordinance for the winter months. This Ordinance is to help get our streets plowed quickly and helps avoid personal property damage.

3-4-33 PARKING DURING SNOW EMER-

**GENCY.** No person shall park, abandon, or leave unattended any vehicle (including but not limited to cars, trucks, boats, trailers, campers, and all forms of recreational vehicle) on any public street, alley, or City-owned off-street parking area except as provided in 3-4-33A and 3-4-33B during any snow emergency unless the snow has been removed or plowed from said street, alley or parking area and the snow has stopped accumulating. Whenever an unauthorized vehicle is found, the authorized municipal officer shall cause the vehicle be towed.

A snow emergency parking ban shall continue through the duration of the snow or ice storm and the seventy-two (72) hour period after cessation of the storm except as above provided upon streets which have been fully opened.

The ban shall be of uniform application. The Chief of Police is directed to publicize the requirements widely, using available news media each year. When predictions or occurrences indicate the need to declare a snow emergency the Mayor or Mayor's designee shall inform the news media and publicize the parking rules under the emergency. Such emergency may be extended or short-

ened when conditions warrant. It shall be conclusively presumed that any snowfall of two inches or more as officially measured at Sioux City, Iowa creates a snow emergency.

### 3-4-33A DESIGNATED PARKING AREAS.

Parking shall be permitted during a snow emergency in the designated parking adjacent to Haskell Pool and the designated parking on the west side of the 200 block of North Fourth Street for periods of up to seventy-two (72) hours of continuous use.

**3-4-33B SNOW EMERGENCY PARKING PERMIT.** The council may grant an emergency snow parking permit, for cause, in individual cases in which compliance would create an extreme hardship. When granted the permit shall be displayed upon the dashboard of the vehicle. All such permits shall expire May 1 of each year.

**3-4-33C MUNICIPAL INFRACTION.** Parking a vehicle in violation of this section four or more times between November 1 and May 1 or leaving a vehicle in a designated parking area in excess of seventy-two (72) hours shall constitute a Municipal Infraction. A civil penalty of \$100 shall be imposed for each such violation, each day a violation continues shall constitute an additional infraction.
